Re: Midway Heritage Development, LLC petition to transfer water rights

Dan Luster, agent for Midway Heritage Development LLC, is petitioning the City to allow him to transfer two separate water rights to the City's Alpenhof wells. Mr. Luster would like to transfer the water rights that will help complete the culinary water requirements for his proposed development called The Village located at approximately 550 E. Main. The first water right is owned by Mark and Jorgene Wilson and is 33 acre feet. The second water right is owned by Holmes Western Deer Springs, LLC and contains 32.07 acre feet. Both rights are from the Provo River. The Water Board reviewed this proposal and made the following recommendations to the City Council:

Motion: Midway Irrigation Member Grant Kohler made the motion to recommend to City Council the approval of the Wilson Water Right Change Application to accept the 11 acres of irrigated land, with 33 acre feet of water which is already in the River Ditch, and it continue into our system to recharge the aquafer and diverted into the Alpenhof and Alpenhof Weber Well. City Councilman Steven Dougherty 2nd the motion.

Mayor/Chair Celeste Johnson asked if there were further questions regarding this item? There was not.

Motion was carried unanimously.

Motion: Midway Irrigation Member Grant Kohler made the motion to recommend to City Council the approval of the Holmes Western Deer Springs Change Application to accept the 10.69 acres of irrigated land, with 32.07 acre feet of water and be diverted into the Alpenhof and Alpenhof Weber Well contingent upon the change application to transfer the diversion of the water to the River Ditch . City Councilman Steven Dougherty 2nd the motion.

Mayor/Chair Celeste Johnson asked if there were further questions regarding this item? There was not.

Motion was carried unanimously.

Re: Water Rights for Dan Luster's development in Midway City

Dear Mr. Gordon:

Attached are copies of two change applications along with print-outs from the State Engineer's records of the water rights associated with each change application.

For Item C in the Foreign Water form, dealing with title to the underlying water rights, when the change applications are approved, title will transfer directly from the current owner of the water rights to Midway City. If you need copies of the contracts for purchase of these right by Mr. Luster, let me know and I will obtain those for you, although, we anticipate that title will transfer directly to Midway City and not through Mr. Luster.

For Item D – historic places of use and points of diversion for these rights. – On the Change Application now owned by Mark and Jorgene Wilson Family LLC, this water has been diverted from the Phil Smith Ditch which is located near the Wilson farm and at the Upper Midway Dam, which is where Midway River Ditch. The place of use is in the S1/2 of Section 24, T3S, R4E,SLB&M, which is on property owned by Mark Wilson. For this change application he will be drying up 11 acres of land.

For the Change Application owned by Holmes Western Deer Springs, LLC, currently there is a change application that has been approved to move this water to be supplied from JSSD. Upon approval of this new change


application the Change Application for JSSD will be withdrawn. This water was historically used on land that is owned by Robert Benson, but Mr. Benson decided to not purchase these rights and moved other water rights on his property to cover his uses.

For Item E – 1 through 7, Both of these Change Applications are based on 1st Class water rights that historically have been used for irrigation purposes from the Provo River. The time of year that this water is available is the irrigation season. The quality of Provo River water is excellent. Return flow can be made from the historical source if needed. It is anticipated by this change application that Midway City's existing Alpenhof – Weber Well will be utilized for this change application. It is not anticipated that there will be any impact on any of the City's existing sources or delivery mechanisms but if there is, the water from the Provo River that was historically diverted can be utilized to mitigate for any impact.

For Item F, since the proposal is to utilize Midway City's Alpenhof- Weber Well for year-round use, it is anticipated that year-round use will be granted by the approval of the Change Applications to be filed for municipal use of water.

All other facilities and appurtenance issues and fees will be addressed by Mr. Luster in a very timely basis. Let me know if you need additional information.


