TOWING AGREEMENT

This towing agreement is between Midway City and Heber Valley Towing, LLC

The above desires to have Heber Valley Towing respond to a call (435-654-3494) and then an email (hebervalleytowing@gmail.com) from an authorized representative of Midway City to have vehicle removed upon request. The address, make, model and color of vehicle will be required.

All Vehicles will be towed to Heber Valley Towing storage yard at 141 E 1200 S, Heber City, UT. All tow and storage fees will be charged to the owner/owners of the vehicle.

The towing fee will be at the Utah State DOT regulated Towing, Administrative Fee, Storage and Fuel Sur Charge (when applicable) rates. As of January 1, 2024 the rates are as follows:

Towing \$201.00 (Vehicle up to 10,000 lbs. GVWR)
Towing \$334.00 (Vehicles 10,001 lbs. 18,000 lbs. GVWR)

Storage fee \$40.00 per day (Vehicle up to 10,000 lbs. GVWR) \$60.00 per day (Vehicles 10,001 to 18,000 lbs. GVWR) or any part of a day. Storage begins the moment the vehicle is in the storage yard.

Administrative Fee \$42.00, The State of Utah requires non consent tows be entered into the state IVS (Impound Vehicle Service) system within 2 hours from when the vehicle is towed.

Fuel Sur Charge based on the price of fuel when over \$3.25 per gallon.
5% of the towing charge added to the total invoice.

Vehicles can be picked up during regular business hours, Monday thru Friday 8:30 a.m. to 5:00 p.m. except holidays. If anyone would like to pick up their vehicle after regular business hours it is by appointment only and there will be a \$75.00 after hour release fee charged.

Fuel surcharge is 5% of the towing charge

This towing agreement is between Midway City and Heber Valley Towing, LLC.

The above desire to have Heber Valley Towing respond to a call (435-654-3494) and then an email (hebervalleytowing@gmail.com) from an authorized representative of Midway City to have vehicle(s) removed upon request. The address, make, model, and color of vehicle will be required.

All Vehicles will be towed to Heber Valley Towing storage yard at 141 E 1200 S. Heber City, UT. All tow and storage fees will be charged to the owner/owners of the vehicle.

The towing fee will be at the Utah State DOT regulated Towing, Administrative Fee, Storage, and Fuel Sur Charge (when applicable) rates. As of January 1, 2024, the rates are as follows:

Towing \$201.00 (Vehicle up to 10,000 lbs. GVWR)

Towing \$334.00 (Vehicles 10,001 lbs. to 18,000 lbs. GVWR)

Storage fee \$40.00 per day (Vehicle up to 10,000 lbs. GVWR) \$60.00 per day (Vehicles 10,001 to 18,000 lbs. GVWR) or any part of a day. Storage begins the moment the vehicle is in the storage yard.

Administrative Fee \$42.00. The state of Utah requires non consent tows be entered into the state IVS (Impound Vehicle Service) system within 2 hours from when the vehicle is towed.

Fuel Sur Charge based on the price of fuel when over \$3.25 per gallon.
5% of the towing charge added to the total invoice.

Vehicles can be picked up during regular business hours, Monday thru Friday 8:30 a.m. to 5:00 p.m. except holidays. If anyone would like to pick up a vehicle after regular business hours, it is by appointment only and there will be a \$75.00 after hour release fee charged.

There will be a \$100.50 show fee to be paid by the vehicle owner if the vehicle is hooked up and they would like it released at the scene. If the vehicle is loaded on the tow truck, the fee is \$201.00.

All major credit cards or cash will be accepted as forms of payment by the vehicle owner.

Heber Valley Towing agrees to indemnify and hold harmless the City of Midway for any negligent acts and/or omissions to act on the part of Heber Valley Towing and its employees and/or agents, arising under this agreement, and agrees to provide proof of insurance in the form of insurance binder or declarations to the City upon request.

This Agreement may be terminated by either party at any time, with or without cause, upon ten (10) days' written notice to the other party.
