Dear Midway City Council,

As you gather to discuss the Midway City TAP tax grant applications and the process, I would first, like to thank you for this wonderful and much needed support. I have developed and managed arts related events in Midway since 2004. It's been a labor of love for 20 years, and a joy to see people come together in our community as artists, performers, supporters and the public at large.

There is always much to learn and every year there are changes, challenges and opportunities for a new program like the TAP tax grants. I would like to offer a little feedback and make a request at this time in regarding the grant applications.

On Monday, January 27, did a search on the internet to look for any new information and dates for the upcoming grant cycle. I typed in Midway City Utah TAP tax grant. I was surprised to discover my name as the heading at the top of the search result. That did not alarm me, but what did alarm me was the fact that my entire application packet for 2024 was published online before it had even been reviewed. It contained all of my personal contact information, my name, phone, email address and home address multiple times. It contained every page of my grant application docs including the pages of photos, recommendations and the detailed budgets I had submitted. A second application by another person was also published with the personal information, as well.

I understand that each member of the council needs a copy of these packets to review them prior to discussion and voting. However, since they are only applications, and not the awarded projects, couldn't they be shared among council members and not published online, especially since the council, not the public, are doing the review to determine which projects will be approved? There are a number of ways this could be done such as virtual data rooms, Microsoft teams, secure board portals, encrypted email services, cloud storage services with access controls and even password protected pdfs.

Also, I would like to recommend that once the applications are reviewed, and the projects chosen and awarded, that a page dedicated to the announcement of awardees be posted online with a simple statement about each project. I suggest that a 250-word description provided by each entity could include the manager's name, the projects name, location, the award amount, a short description and the website address link where more information could be obtained by the public. It would recognize the projects; inform the public of the ways the TAP monies have been awarded and provide a little advertisement.

About Me

My name is Carrie Dayton-Madsen, founder of Sleepy Sun Studios, a new initiative dedicated to reviving community dance. Growing up in Wyoming, I learned from my grandmother how vital dance is for building social bonds. Dance provides a space for individuals to gather, support each other, and experience joy. Having lived in Utah for 29 years, I have observed a growing need for activities that foster social connections. This project aims to address that need by creating inclusive community dance events in Midway.

Services the Project Will Involve

This project will host inclusive community dance events in Midway, welcoming individuals of all ages and backgrounds. While a small entrance fee will be charged, it will not cover initial expenses. I am seeking a grant to fund essential equipment, including a PA system, and to cover live music fees. The funds will support the launch of the community dance initiative at the Midway Town Hall. Initially, we will use recorded music, but, when possible, I will hire live musicians to perform as I teach and call the dances.

Potential Impact on the Local Arts Scene

My goal is to unite dancers and musicians to create a vibrant and sustainable dance community. Community dance nurtures the local music scene by providing musicians with a platform to practice, collaborate, and grow their craft. As a board member and caller with Wasatch Contras non-profit in Salt Lake City, I have seen the positive impact of contra dance firsthand. Currently, there are no contra dance opportunities in my county, and I am committed to filling this gap.

Learning Opportunity for Musicians

In a pre-dance workshop, musicians will learn how to play music that fits the rhythm and meter of contra dance. Contra music has specific beats-per-minute (BPM) and a structure that aligns with dance steps. I will demonstrate essential elements, and more experienced musicians will offer in-depth insights. Musicians will learn how to adapt their style for contra dance and understand the differences between community dance music and performance pieces.

Cultural Significance of the Project

Contra dance is a participatory art form that fosters social cohesion and serves as a community hub. It has long played an integral role in life celebrations, such as holidays, weddings, and seasonal events. This project will provide a space for the community to connect through movement, music, and tradition, strengthening bonds and creating a joyful atmosphere of unity.

Ability to Conduct the Project

With 15 years of experience as a dancer and 10 years as a board member of Wasatch Contras, I have been a contra dance teacher and caller in regular rotation with Wasatch Contras for the past

two years. I have called with other dance organizations prior to Wasatch Contras for four years. While I am an intermediate-level caller, I am dedicated to refining my craft and establishing a long-lasting contra dance series in the Wasatch Valley. My goal is to offer opportunities for people of all ages to come together through social dance, fostering a stronger community.

My Experience with Contra Dance

I grew up in a chaotic, violent environment, struggling with coordination and low self-esteem. Despite these challenges, I loved music and dancing, though the spaces I saw dancing often involved heavy alcohol use. When I first attended contra dance, it felt easy, and the teacher was patient. I also noticed that it was a sober, wholesome activity that all ages could enjoy. The dance became a safe space, helping me learn to self-regulate and boosting my self-esteem. Over time, contra dance has transformed my life, and now I'm excited to share this healthy, inclusive environment with others. I am also producing my first contra dance weekend in Idaho in February 2025 with my husband.

Summary of the Project

During the grant period, I will host four community dance events, each starting with a 30-minute beginner workshop. The evening will feature simple dances, gradually increasing in difficulty based on participants' comfort levels. Each event will include two sessions: a 2-hour first session (including the workshop) and a 1 to 1.5-hour second session.

- **Total Amount Requested: \$2,500**

The PA system is essential for clear communication and calling, ensuring all dancers can hear the instructions. Contra dance relies on the PA system to project the caller's voice across large spaces. I consulted with Mike Cottle, director of the experimental music studios at the University of Utah and a regular caller with Wasatch Contras, to select the most effective equipment.

How the Funds Will Be Used

The grant will primarily cover the purchase of a PA system to amplify my voice during the dances. Additionally, I will hire a live band for one of the events, incorporating a pre-dance workshop for musicians to learn how to play for contra dances. This will help bridge the dance and music communities while enriching the local music scene.

Charitable Acts Theatre Midway TAP Grant Application

Description of Event:

The Midway TAP Grant will be used to begin a youth acting/singing/dancing workshop series, with current film and Broadway actors teaching the classes. It will be an opportunity for Midway and Heber youth to learn from professionals in an intimate setting, who will instruct, encourage, support, and help each youth to hone their craft, which in turn will increase their self-confidence and self-worth.

More information:

CAT has established a relationship with Kate Reinders and Andrew Samonsky (they are married), who have established their permanent residency in the SLC area. Some of their credits include:

Kate Reinders - Film credits include Miss Jenn in High School Musical: The Musical: The Series, Colleen Ferraro in Russell Manic, and others. She has also starred in several Broadway productions, including Something Rotten!, Wicked, and Beautiful: The Carole King Musical. She is currently filming a new series for Disney+.

Andrew Samonsky: Andrew has several film credits but is most known for his Broadway performance in the Tony Award winning revival of South Pacific, the Mystery of Edwin Drood, and Scandalous. He previously toured the country in Come from Away, and is currently touring with the show Parade.

Kate and Andrew have a passion for helping people, especially youth. They are looking for opportunities to help the youth in our community, and they are excited to begin a workshop series. They recently toured Midway and Heber City, along with their parents and son. Everyone was particularly awed by the beauty of Midway, and they feel that they want to be a part of the arts scene there on an ongoing basis, as their schedules permit. This workshop will be the beginning of a permanent CAT Youth Workshop Series. Andrew and Kate have friends with experience in all aspects of performing arts, both theatrical and film, who can teach in future workshops.

How Midway will benefit:

First and foremost, it is always beneficial to invest in our youth. The CAT youth workshops will help the youth of Midway and surrounding areas to become more confident, develop their talents, and help each youth to have access to professional direction. From these workshops we hope to inspire them artistically, which in turn help make them better individuals, community members, future employers/employees, and parents. The power that the arts can have in the lives of teens cannot be understated.

Secondly, Midway has been established as one of the greatest arts supporting cities in the county. The Midway Town Hall is the premiere theatrical space in the area, and people come from all over to be involved in the many successful productions and events that take place in Midway. We hope to add the CAT workshops to that list of artistic events that Midway is known for. If we couple that with the professional actors, we will draw more people to Midway for these workshops, which in turn stimulates the economy. Youth will eat locally before/after the workshops or performances, or their parents will stop at the bookstore or chocolate shop while they wait. They may decide to make reservations for a future date at one of the beautiful resorts. The possibilities are endless, but it will all benefit the Midway community.

Where:

We have looked at other locations to implement the workshops, but none have the space and versatility of the Midway Town Hall. A large area will be needed for dancing, stage movement, etc. We are currently unsure what the capacity will be for each workshop, but the Midway Town Hall will be able to accommodate any participant size.

When:

We anticipate that the workshops will be held on three separate days, possibly one per week for three weeks, most likely with a free family/friends performance on the final day. The dates of the workshops will depend on Kate and Andrew's work schedules and the availability of the Midway Town Hall. We hope to have the first one around mid February to early March 2025.

Who Will Attend:

As stated previously, we will advertise to Midway/Heber City because we want to focus on local youth. However, if the classes don't fill up after some time, then we will advertise to Park City and surrounding areas. Having said that, with the popularity of Kate and Andrew, especially Kate because she starred in the High School Musical Series on Disney+, we believe there will be a great response from local teens, and the workshops will fill up quickly. We will charge a fee for the workshops, but it will be clear that scholarships will be available for anyone who cannot afford the cost. We don't want anyone turned away. The money paid by the youth will go to CAT to pay for administrative costs such as insurance, storage fees, accounting services, etc, as we always donate the proceeds from all of our plays to local charities.

Cost:

Our budget is as follows:

Town Hall rental/cleaning fees - \$500 per day, \$1500 total

Advertising - Banners (new) \$2071, yard signs \$348, posters \$70, print ads \$40, social media sponsored marketing \$450, which is **\$2979 total**.

Advertising Note We learned from our recent Halloween Event, that an overwhelming majority of people in the valley respond to banner advertising, and often it is the only advertisement that they see. We will need to print new banners, but hope to do it in a way that we can reuse them for future workshops.

Any costs associated with ads artwork/creation will be paid for by CAT.

Compensation for Professional Instructors - \$500/each per workshop, **\$3000 total**.

Compensation Note

CAT feels we must offer compensation for Kate and Andrew's time, because they are working professionals. We also want to establish a long term relationship with them and their friends who would be willing to facilitate/teach in future workshops and paying them shows we are serious about this relationship. We have not yet discussed a compensation amount with them, but this is the amount we are hoping to settle on. They are also contacting the Actors' Equity Association to see what they are allowed to do, and whether or not it is required for us to pay them, and how much that might be. If they are required to receive more compensation, then CAT will provide the difference.

Food/Snacks for breaks - \$100/day, **\$300 total**

Notebooks and Pens for Youth - **\$150 total**

Customized Free T-Shirts - \$13/each, approx 50 youth, **\$650 total** (Any amount above this will be paid for by CAT)

Grand Total - **\$8,579**

To Midway City Mayor and Council,

The Rocky Mountain Carvers Roundup began in 2021 and was held at the Zermatt Resort for the first 2 years. Initially featuring five instructors and 44 attendees. The event has grown each year, attracting more visitors to our beautiful valley. Now the event is held in the historic Midway Town Hall, allowing the entire group to be together.

All attendees, often accompanied by significant others, stay and dine locally. Last year alone, over 450 room nights were booked in local hotels and campgrounds, along with 2-3 meals purchased at local restaurants each day. 75-80% of attendees come from out of state.

This year, we anticipate over 120 carvers and 12 world-renowned carving instructors. Throughout the day, locals are welcome to visit the Town Hall to observe the event live. In the evenings, various activities will be available for locals to enjoy, including carving lessons, painting instruction, a concert in the park, and a delicious smoked BBQ dinner.

One of the highlights of last year's evening activities, in addition to the nightly carving activities was a private train car ride on the Heber Valley Railroad, an experience that will be offered again this year.

The Rocky Mountain Carvers Roundup benefits the city by increasing tax revenue, and local businesses profit from the attendance of nearly 200 people.

With the awarding of a TAP Fund Grant, the funds will greatly assist with marketing, advertisement, and evening activities for locals including our BBQ dinner, Thursday night concert, and more.



WASATCH TRAILS FOUNDATION STAFF REPORT FOR ANNUAL BACKCOUNTRY TRAIL MAINTENANCE

Presented by: Executive Director, Mia Yue and Board President, Scott House

Summary

There are roughly 175 miles of public backcountry trails in Wasatch County. Maintenance on trails can cost anywhere from \$1,000-\$5,000 per mile depending on what type of maintenance the trails need; in order to ensure safe, sustainable trails, professional trail builders are required. At its minimum it would cost roughly \$175,000 per year and at its maximum it would cost roughly \$875,000 per year to properly maintain our trails. This funding is crucial for ensuring the safety and resiliency of our trails, which have become an integral part of our mountain valley's outdoor recreation offerings and access to open space. Not only do our trails have a significant impact on our local economy, they provide an important health benefit to our residents, mentally, emotionally, and physically. The recommendation is to include dedicated funding in the upcoming fiscal year's budget to allow for continued maintenance of these important community assets.

Recommendations

The Wasatch Trails Foundation proposes the addition of a new budget line item in the amount of \$45,570 for the next two years as a pilot program for hiring back the Wasatch Trails Foundation trail crew. This funding will allow the Wasatch Trails Foundation to ensure that Wasatch County open space remains accessible through a safe and sustainable trail system. This will be accomplished by addressing necessary repairs, vegetation management, and erosion control on an ongoing basis.

Background

In 2023, Wasatch County paid for and put out a survey to find out what really mattered to their residents. 72% of respondents stated that the "best things about the county" was access to the outdoors, specifically trails. Trails provide a host of economic and social benefits, making them invaluable assets to our community. Backcountry trails enhance property values, making surrounding areas more attractive and boosting real estate appeal. A study by Perry, Castaneda, Parece, and Casey (2017) found that homes within close proximity to natural amenities have a higher value than other homes, controlling for important characteristics of the home. Living within 250 meters of a trail increases home values by 4.54%, while living within 500 meters of a trail increases

home values by 3.26%. For the average home value in Wasatch County of approximately \$800,000, this equates to home value increases of approximately \$36,320 and \$26,080, respectively. (Grand Valley Public Trails Systems Socio-Economic Study. Mesa County, Colorado 2018). Trails also support local businesses, including restaurants, hotels, and retailers, who benefit directly from increased spending, as trails attract both residents and visitors eager to explore and enjoy nearby amenities. Trails are a crucial driver of small-town economies, often serving as a primary reason for their success. Beyond economic impact, trails offer low or no-cost recreational opportunities for families, particularly benefiting those with limited incomes. By promoting active lifestyles, trails also contribute to healthier communities.

The Wasatch Arts Council and Wasatch Trails Foundation have been instrumental in advancing these benefits by helping pass Prop. 3, also known as the TAP Tax, which brings in roughly \$1.2 million dollars annually in tax revenue. Many towns see tourism primarily because of their trails, underscoring the role these outdoor spaces play in fostering economic growth and community well-being. Wasatch County is no exception, with outdoor recreation being a vital component of our overall economic health.

The U.S. Department of Commerce's Bureau of Economic Analysis (BEA) has released economic data for 2022 exhibiting outdoor recreation's powerful and positive economic impact on the U.S. economy.

Key Highlights from the 2022 data on Utah's outdoor recreation economy:

- \$8.1 billion in economic output; up 32.79% from 2021 to 2022
- 3.2% of Utah's GDP
- 71,677 jobs created

This impressive growth highlights the increasing importance of outdoor recreation to Utah's economy. Investing in the maintenance of these trails is not only essential for public health, safety, and enjoyment, but also supports the broader outdoor recreation economy, which continues to be a driving force for growth and job creation.

With the increased demand on our trail systems, health benefits and economic significance, it is essential that we secure a dedicated funding stream for regular maintenance to keep these assets in top condition.

Fiscal Impact

The fiscal impact of this request is \$45,570 for the next two years, beginning in the next fiscal year. This budget line item will be drawn from the general fund or TAP Tax fund and used exclusively for the employment of the Wasatch Trails Foundation trail crew, in

order to upkeep and build new trails in Wasatch County when deemed appropriate. The trail crew will focus on various tasks, including:

- Trail inventory and collaborative trail maintenance planning.
- Routine trail repairs and resurfacing including but not limited to, corridor clearing, side vegetation control, and erosion control.
- Inspection and repair of infrastructure, such as signage, bridges, and trailhead infrastructure.
- Emergency trail repairs following weather-related damage

This dedicated funding, based on 35% of the total cost to bring back the trail crew, will reduce the need for larger, more costly repairs in the future by ensuring regular upkeep of the trail system.

Note: This funding request is based on maintenance occurring from April 15th-November 15th with a 3 person trail crew working full time (40hrs/week)

120 hours x 31weeks x \$35/hour = \$130,200 total cost for crew

35% of \$130,200 = \$45,570

Conclusion

An annual budget allocation of \$45,570 for backcountry trail maintenance represents a proactive measure to protect one of Wasatch County's most cherished recreational resources, as emphasized by local residents. This funding will enhance the safety and accessibility of open spaces, accommodate increasing public use, and affirm the county's commitment to preserving natural areas and addressing community priorities. Approval of this request will help keep the trail system a valued asset for the community for years to come.

Midway Social Hall/Cannery Building – Stained Glass Panels

Overview

Midway's historic Social Hall/Cannery Building is owned by Midway Boosters, a nonprofit 501c3 organization. The building was constructed in 1896 and is on the National Historic Registry. The building has been undergoing restoration. The goal for Midway Boosters is to allow the building to function better for community events and meetings while preserving the building for future generations. The work being proposed under this TAP request contributes to the continued character of Midway's Main Street and our Swiss heritage.

Work Completed to Date

Boosters has funded historically appropriate renovation of the two front rooms including the east room which is now set aside for Swiss Bells and a meeting room on the west. A new HVAC system has been installed, new stairs were fabricated for the north door (egress from the baking area), but remediation is underway for the attic, the bathroom has been renovated and restored, and rain gutters and snow cleats help divert water from the building. Engineering and strengthening of the roof trusses still needs to be completed.

Work Proposed – Request for TAP Funding

On the front of the building, three art panels (designed with a Swiss theme) were installed in the 2014. The panels are positioned above the front door and front windows. The windows were painted to resemble stained glass. However, the paints have run and faded in the hot sun (see attached photos). This request is to replace the three panels with actual stained-glass pieces that are cut and assembled to replicate the current Swiss-themed designs. As part of this project, the backlighting will be replaced with LED (warm white) fixtures to illuminate the panels at night. Funds from this TAP request will be used to purchase the glass, fabricate the new stained-glass panels, remove the old panels, install the new panels, and install the LED backlighting.

What This Project Accomplishes

The project will lend historic charm to Midway's Main Street. It should be noted that the building has been included by the Midway Historic Preservation Committee in a 28 building Midway Historic Walking Tour, and this proposal has the support from members of the Midway Historic Preservation Committee.
