2025 APPLICATION TIMELINES

Funding for the July-December 2024 period will take place in February 2025.

In 2025, there will be two funding periods. (Spring & Fall)

Fall Funding Timeline	
July 1, 2025	Funding application period open
September 30, 2025	Funding application period close

October 15, 2025	Applications submitted to City Council
November (1st Tuesday)	City Council review during work meeting/funding finalized during regular meeting
December	Contracts signed / funds dispersed

Notes:

- We have updated our application to request more information and an itemized budget from applicants.
- Beginning with the grants awarded in February 2025, all grant applicants who receive funding will be required to sign a contract with the city.
- Funds not spent when the new fiscal year budget starts (July) will be moved into a TAP CPI fund.
- The average monthly amount Midway received in 2024 was \$17,650
- There is currently \$188,261 in our TAP CPI fund.
- There is \$103,009 in the general TAP fund as of December 2024.

Going Forward in 2025:

- Should the city use of TAP funds be for "as-needed" use, or should City project funds be requested in the funding period?
- Should a scoring rubric be implemented to score applications before submitting them to the council for a final decision?
- Are there budget items the council would like to exclude from funding requests? (i.e. scholarships, administrative costs, etc.)
- How should TAP funds be used to cover building rental costs, and what types of events will qualify?
